RE Official information request CDHB 10526

I refer to your email dated 15 January 2021 requesting the following information under the Official Information Act from Canterbury DHB. Specifically:

1. Please provide a monthly breakdown of the number of people treated at Canterbury District Health Board from 2016 to 2021 to date (including through the COVID-19 period) for MDMA related admissions. Can you please break it down by age groups of those treated and ethnicity.

Please refer to **Appendix 1**, which contains data on the number of people who presented at Canterbury DHB's emergency department from 2016 to January 2021 for MDMA related symptoms. This data is split into three Tables and is broken down by month for each year requested, and also by age group and ethnicity for the calendar years 2016 to 2021.

Please note: the data shows numbers presented at the emergency department (ED) by arrival date, where either MDMA or Ecstasy has specifically been noted. It is not mandatory to gather data on specific drugs and additionally MDMA may not have been the primary reason for presentation so may not have been noted at the time.

2. Please provide a monthly breakdown of the number of people admitted to Canterbury District Health Board from 2016 to 2021 to date (including through the COVID-19 period) for MDMA related harm. Eg for those who have injured themselves with MDMA in their system. Can you please break it down by age groups of those admitted and ethnicity.

Please refer to **Appendix 2**, which contains data on the number of people admitted to Christchurch Hospital from 2016 to December 2020 for MDMA related harm (those who have injured themselves with MDMA in their system). This data is split into three Tables and is broken down by month for each year requested, and also by age group and ethnicity for the calendar years 2016 to 2020.

3. Please provide a monthly breakdown of patients admitted to Canterbury District Health Board from 2016 to 2021 to date (Including through the COVID-19 period) for consuming substances disguised as MDMA e.g. Synthetic Cathinones.

Canterbury DHB is unable to provide a breakdown of patients admitted to Hospital for consuming substances disguised as MDMA (for example, synthetic Cathinones) as this information is not coded and collated in a central database that can easily be accessed or reported on. This information may be contained in an individual's clinical notes; however, we would need to manually search the clinical notes of each individual patient presenting at the emergency department or admitted into hospital during this requested timeframe in order to provide a response.

We are therefore declining to provide a response to this part of the request pursuant to section 18(f) of the Official Information Act, i.e. "that the information requested cannot be made available without substantial collation or research".

4. Please provide a monthly breakdown of the number of people who have died from MDMA related harm at Canterbury District Health Board from 2016 to 2021 to date (including through the COVID-19 period).

Canterbury DHB is unable to provide a breakdown on numbers of people who have died specifically from MDMA related harm, as this information on cause of death is not coded and collated in a central information system that can be reported on. Information on cause of death may be contained in a patient's individual clinical notes but searching for this data would require a substantial amount of time.

We are therefore declining to provide a response to this part of the request pursuant to section 18(f) of the Official Information Act, i.e. "that the information requested cannot be made available without substantial collation or research".

5. Please provide a monthly breakdown of the cost for each person who was treated at Canterbury District Health Board from 2016 to 2021 to date (including through the COVID-19 period) for MDMA use.

Please refer to **Appendix 3**, which shows the total cost of **both** MDMA presentations at Canterbury DHB's Emergency Department and admissions into Hospital (by discharge date) between the years 2016 and 2020. Costs for calendar years 2018 to 2020 (to date available) are broken down by the month in which presentations and discharges took place.

Please note: During the calendar years 2016 and 2017, not all costing information was entered into Canterbury DHB's PPM costing data system in relation to MDMA presentations and admissions. Consequently, the monthly data for these two years is incomplete. We are therefore providing annual costs only for these two calendar years, as a rough indication of costs spent by Canterbury DHB.

I trust this satisfies your interest in this matter.
