RE Official Information Act request CDHB 10107

I refer to your email dated 16 May 2019 and received on 17 May 2019 requesting the following information under the Official Information Act from Canterbury DHB regarding Ophthalmology outpatients. Specifically:

I would appreciate it if you could let me know over the past 3 months:

Please note the information we are providing (February 2019 – April 2019) is not a representative three month period as during those months we experienced: the Mosque attacks (15 March 2019) which meant that our theatres and other clinical resources were interrupted in favour of providing an emergency response to the victims of this attack and the Outpatients Building flood (29 March 2019), which resulted in the Ophthalmology Department clinics being closed for five weeks.

In response to the disruption caused by the flood we were able to relocate some activities to Burwood Outpatients, Southern Eye Service, various other providers and the inpatient ward area, at short notice. This did however, have significant impact on patient flow and staffing. We estimate in the region of 5000 patients overall (not just eyes) were affected during the Outpatients Building disruption and closure. We currently have a backlog in the region of 2500 patients, which we are actively addressing by running additional afterhours clinics.

1. How many patients, on average, were seen per ophthalmologist's OPD clinic (i.e. morning or afternoon clinic)

Please refer to **Appendix 1 Table one** (attached) for the average Ophthalmology attendances by Clinic and Clinician between February 2019 and April 2019. To give you some comparison, while there were 10,467 attendances over the period requested, there were 12,747 attendances over the same three month period in 2018.

2. Whether the ophthalmologist had a registrar assisting

Many clinics also have a Registrar attached and this typically allows for an additional 6-12 patients to be seen (average 9 patients per morning or afternoon session).

3. The number of patients, on average, seen by the different ophthalmologists (not to be recognizable but just labelled A, B, etc.

Canterbury DHB employed 20 Ophthalmologists during the time frame requested and they saw a total of 4,133 attendances between them. This gives an average of 207 attendances seen per Ophthalmologist over the three month period. Note: not all Ophthalmologists work full-time and this does not include Registrars.

4. The total number of *patients* seen over the period.

The number of distinct patients seen between February and April 2019 was 6,770
