**RE Official information request CDHB 10360**

I refer to your email dated 21 July 2020 requesting the following information under the Official Information Act from Canterbury DHB. Specifically:

- **The total sum paid to each medical college by your DHB on behalf of all medical practitioners. For the avoidance of doubt, this is sums paid by the DHB directly to medical colleges and through reimbursements on behalf of SMOs and RMOs. (Clarified as being for the last financial year.)**

We do not hold the information requested in an easily retrievable electronic data system and are therefore declining your request pursuant to section 18(f) of the Official Information Act.

College fees are primarily paid by the relevant doctor and reimbursed through Payroll. When the College membership fees are reimbursed for both SMO and RMO, our Payroll system does not display which college has been reimbursed.

This means we would need to go back to source documents and given the volume of the task for Canterbury DHB, this would take a considerable amount of time and resource.

**Please note:** The Canterbury DHB employs 688 (563 FTE) SMOs and 637 (564 FTE) RMOs.

**Please also note:**

Section 28.3 from the **RDA MECA** says: *The employer will reimburse the annual cost of membership of relevant postgraduate colleges to eligible employees.*

## **STONZ MECA**

Section 10.3 states: *The employer will reimburse the costs of membership of postgraduate colleges and other associated bodies required as part of a vocational training programme.*

Section 21.2 from the **ASMS MECA**:

### 21.2 Work-Related Expenses

- (a) the annual practising certificate, including disciplinary levies;
- (b) other necessary licences e.g. radiation licence;
- (c) Medical Protection Society membership or an agreed alternative;
- (d) vocational registration fees relevant to duties and responsibilities with the employing DHB;
- (e) college membership fees, where membership of the particular college(s) is necessary for the employee's employment;
- (f) membership of other approved professional associations relevant to the employee's duties and responsibilities;
