### RE Official Information Act request CDHB 10075

I refer to your email dated 4 April 2019 requesting the following information under the Official Information Act from Canterbury DHB.

- **Data (including revenue, expenditure and patient/bed counts) related to use of aged care facilities in the Canterbury region, in particular, in Christchurch if possible. Ideally, I am looking for both historic information (say back 5 years), and projected/forecasted into the future (say to 2030).**

An indication of the revenue providers receive can be calculated using the document attached as **Appendix 1**. Prices change on 01 July each year.

Over the past few years we have had more consistent admission criteria. This means that some people admitted at rest home level of care prior to 2015 would not be eligible under the current criteria. They would be supported to live in their own home.

I trust that this satisfies your interest in this matter.
