RE Official Information Act request CDHB 10681

I refer to your email dated 6 August 2021 requesting the following information under the Official Information Act from Canterbury DHB. Specifically:

At Christchurch Hospital A&E during the period of Friday 30th July to Tuesday 3rd August...

a. Please could I have a sex and age break down of causes for all admissions, and numbers thereof, under diagnostic headings, e.g.: blood clots, heart issues, breathing difficulties, RSV, anaphylactic shock, accidents ... etc?

Please can the breakdown include numbers of people whose admissions were subsequent to Covid vaccination and the time frames: a) In the prior 2 weeks, b) the prior week, c) the prior 48 hours, d) The prior 24 hours?

Please find attached as **Appendix 1** presentations to our Emergency Department (ED) for the time frame requested. We are providing you with the top 20 presenting complaints to ED, broken down by age bands and gender. **Note** we are declining to provide patient numbers less than 5 pursuant to section 9(2)(a) of the Official Information Act to protect individual privacy.

We <u>do not</u> match Covid vaccination data with ED presentation data as per the second part of your request and it would take a substantial amount of time and resource to provide the specific information requested. We are therefore declining this part of your request pursuant to section 18(f) of the Official Information Act.

You may, under section 28(3) of the Official Information Act, seek a review of our decision to withhold information by the Ombudsman. Information about how to make a complaint is available at www.ombudsman.parliament.nz; or Freephone 0800 802 602.
