



## **RE Official information request CDHB 10565**

I refer to your email dated 18 March 2021 requesting the following information under the Official Information Act from Canterbury DHB. Specifically:

- I am requesting the Canterbury DHB release all correspondence it has had with Kāinga Ora, the Ministry for Housing and Urban Development, or any other party regarding the DHB's intention with the land that was previously Christchurch Womens Hospital, at 885 Colombo Street. My request is for the DHB's correspondence with those parties that expressed interest in the land.
- 2. Further to my request, I ask that the DHB release all reports, plans or any other documentation which discusses the future use or intention with the land where the Christchurch Womens Hospital used to be.

Please find attached as **Appendix 1** correspondence requested.

**Note:** We have redacted information pursuant to section 9(2)(a) of the Official Information Act i.e. "...to protect the privacy of natural persons, including those deceased".

As advised on 16 March 2020, Canterbury DHB's Board is yet to decide on whether the land is strategically important for the DHB's future facility plans. As disposal has not been considered, no reports, plans or any other documentation discussing the future use or intention in relation with the land is held.

Before any DHB can dispose of DHB land, its Board needs to formally declare it surplus to requirements. If it was formally declared surplus to requirements, there is a strict statutory disposal process the DHB must adhere to before it can be disposed of which involves public consultation, Board and Ministerial approval.

I trust this satisfies your interest in this matter.


