## **RE Official information request CDHB 10341**

I refer to your email dated 25 June 2020 requesting the following information under the Official Information Act from Canterbury DHB, regarding the Canterbury DHB Annual Report 2018-2019 which details the Remuneration of Employees in numerous bands between \$100,000-\$109,999 and \$680,000-\$689,000. Specifically requesting:

• For both 2018 and 2019 would you please provide me with a schedule that details the number of employees in each of the bands with employees classified as either medical/paramedical or management /administrative

Please refer to **Appendix 1** (attached). **Please note:** we have aggregated the information over \$500k pursuant to section 9(2)(a) of the Official Information Act to protect the privacy of individuals. Owing to the small numbers it may be possible to identify these people.

**Please note:** The number of employees earning more than \$100K in 2019 increased by 429 over the previous year. Of those 429, four hundred were medical, the vast majority of whom had salary increases based on a MECA settlement.

A MECA (Multi-employer Collective Agreement) would cover for example our pay and conditions agreements with RMOs (trainee doctors), nurses and midwives – together they make up a significant proportion of our workforce and all had MECA agreements signed in 2019 that awarded significant pay rises, with some backdated to the expiry of the previous MECA agreement.

For example, the nursing MECA alone would have changed the salaries of more than 4,000 nurses employed by Canterbury DHB, of whom some senior nurses and midwives would have crossed the \$100K threshold, especially as the settlement included a lump sum paid during 2019 which is included as part of their income for that year.

All RMOs would already be on a pro-rata salary of >\$100K but the MECA settlement may have moved them up a salary band, again including lump sums and backdated payments made during 2019.

I trust this satisfies your interest in this matter.
