- Kaumatua CDHB hui with MKWT Tumuaki and Teputy Tumuaki re mental health proposal. Staff and employment union attended by Teputy Tumuaki. Plan for another hui with CDHB Executive Director, CDHB Kaumatua, MKWT Teputy and Tumuaki re treaty relationship.

ACTION Email to CDHB Kaumatua determining when this hui shall be held by Tumuaki.

7.8 Rūnaka Reporting:

- Ōnuku – CPHAC/DSAC attended; TKOPT key messages e.g. equity and new members putting themselves forward into Māori rep positions
- Tūāhuriri – CPHO budgeting review e.g. systems level measures discussed. Tuahuriri building houses at Tuahiwi
- Koukourārata – joining Manawhenua Te Waipounamu. Health strategy developed by Papatipu Rūnanga. MKWT already invite Ngāi Tahu to Board Hui. Climate Change – how does this impact policies. Consider staff numbers hauora and environmental portfolios. National Māori Women's Welfare League Conference 2020 to be held in Ōtautahi.

Manuhiri	<p>10.0 Sandy arrived at 1225. Nga Mihimihi by Tumuaki alongside with Elizabeth. Acknowledged Matea Gillies, another Past MKWT Tumuaki. Thank you for taking up your role with Waitaha PHO. Rūnanga Mihimihi – Tūāhuhiriri (influential; whānau ora navigators); Wairewa (memorable with past MKWT achievements); Koukourārata (mentoring initially when joined MKWT); Taumutu (acknowledgement from daughter); Kaikōura (someone to look up to; fruitful for others in the future; rebranding Waitaha PHO tino pai).</p> <p>10.1 Sandy resides in Te Tai o Poutini. Eager to have someone from Waitaha hence resignation. Sandy has been contracted by Waitaha PHO scoping Māori health management position; who the Māori navigators 0.8FTE are accountable to and ensuring it is beneficial for whānau; agency and/or whānau ora commission issues.</p> <div data-bbox="565 1171 1243 1472" data-label="Image"> </div> <p>10.2 Hector and Matthew arrived at 1256. Discussion Points - Hui between MKWT and CDHB Chairs hui on 7th June; Korowai Te Atawhai proposal.</p> <p>10.3 Hector’s korero – Minister of Health talking on Māori Equity and Prime Minister on Children’s Health. Conversations on “what is equity” within DHB’s. A paper written by Hector reported Māori equity is based on three key points:</p> <ol style="list-style-type: none"> 1. Ethnicity measure of staff – 14% in Canterbury 2. Proportionately of Māori in community – must set a target e.g. Tairāwhiti 50%, Canterbury 10% e.g. Ara, Otago University 3. Cultural competence.

ACTION Hector to email paper to MKWT via Kaiawhina

Solution – put Treaty of Waitangi in health; education; employment panels (think in other ways re TOW); HR; policies; broad definitions:

Definitions - Unequal outcomes with unjust. Inequity results in unfairness and unjust resources. Systemic bias e.g. tertiary education required for health professionals.


10.4 CDHB equity – what can MKWT do? Insist CDHB CEO and Board not just health outcomes BUT health equity and cancer e.g. high instances yet low screening rates. New CDHB on 23rd November 2019 as elected by Canterbury residence. Consider for CDHB at first meeting to ensure a presentation on equity.

10.5 New position yet to be advertised looking at all health pathways – equity and diversity role. Equity is a treaty consideration and for MKWT to approach CDHB at every given opportunity – if get it right for Māori, got it right for ALL.

10.6 At 1331 Matthew presents his power point titled “Equity and Hauora May 2019”. MKWT can influence CDHB as knowledge is power e.g. develop workforce as currently no data collected re Māori staff or ethnicity; Muslim and linguistic workforce; develop Māori and Pasifika leadership e.g. recruitment.

10.7 There can be inaccurate data behind routine data. Accurate data:

- Life expectancy for Māori in Canterbury is a 2.5 years difference with Other. Nationally for Māori the difference is 7 years
- Amendable mortality (preventable deaths) for <74 years – Māori in Canterbury are doing well compared to national figures. Cannot deny the present gap however between Māori and non-Māori
- Evidence suggests Māori health statistics is starting to slip
- Population growth and society is changing e.g. growing Māori population in Canterbury could be due to earthquake workforce, births, corrections
- Statistics collected from census suggests PHO enrolments (80%). A research patai is “who are the 20% not enrolled?” (5-7000)
- Hospitalisation (that should have been primary care provision):
 1. Children <5 years – Māori under total rate but higher in 2018 ?asthma
 2. Oral Children <5 years – Māori improved 50% due to PHO dental Services
 3. Lung CA – Māori have a significant difference accessing First CA Day of 21 days e.g. awareness, diagnosis, onto CA pathway
 4. Cervical CA – Inequity with screening between Māori (51%) and non-Māori (68%). Improvements due to school rates e.g. HPD vaccinations (2009-2018), early detection = cure, HVP self-screening (2 years away from collecting data)
- Tiriti o Waitangi (Article 3) as a founding living document determines an obligation of equity, effective health care services and active, healthy living conditions.
