### RE Official Information Act request CDHB 10176

I refer to your email received on 29 August 2019 requesting the following information under the Official Information Act from Canterbury DHB related to measles notifications and test results. Specifically.

- **The number of samples tested by the National Measles Laboratory for measles**
- **The number that tested positive for measles**
- **The genotype of the positive measles viruses**
- **The number of samples that tested positive for the measles vaccine virus.**

We are declining your request under section 18(d) of the Official Information Act i.e. “...the information requested is, or will soon be, publicly available”. The Ministry of Health’s Immunisation Team are working with the National Measles and Rubella Laboratory (NMRL) based in Christchurch, in responding to a Written Parliamentary Question for a request similar to the information you are seeking and the response will be made publicly available on the Ministry of Health website in the next six to eight weeks.

**Please note:** The Ministry of Health and Canterbury DHB have responded to numerous Official Information Act requests over the past months in relation to the Measles Outbreak and our responses are posted on our websites.
