RE Official Information Act request CDHB 10825(a)

I refer to your email dated 4 April 2022 requesting the following information under the Official Information Act from Canterbury DHB. This request being a follow up request to our response to CDHB 10825. Specifically:

I see from my initial request that the waste is not tracked from individual areas within the sites, but by the site in general.

1. Can you please send through the volumes of waste generated per each site (Central, Burwood, etc)?

Also I see from the Healthcare waste policy that section 2.4 indicated that all hazardous and controlled waste should be recorded in a log book. If possible

2. could you please send me through the volumes of hazardous and controlled waste generated by the CDHB sites (Central, Burwood, etc)?

Please refer to **Appendix 1 Tables one and two** (attached) for volumes of Clinical Waste and General waste. **Note** Waste Management only started weighing and recording on each site in June 2019 so the information for general waste is from June 2019 to February 2022. For Medical (Clinical) Waste we are providing the information broken down into each site from July 2018 to February 2022. We are unable to provide this break down of information for the past ten years as requested. (Declined pursuant to section 18(g) of the Official Information Act.)

3. Thank you for the information regarding the total number of surgeries completed and the breakdown of these. Could you please let me know if these are tracked per site? If these are can you please let me know the breakdown of surgeries per site (Central, Burwood, etc) for the past 10 years if possible. (I don't need the breakdown of the types of surgeries per site like was provided previously, just the total number completed per year.)
