**RE Official information request CDHB 10032**

I refer to your email dated 31 January 2019, requesting the following information under the Official Information Act from Canterbury DHB regarding DHB Parking. Specifically:

**I request the following information for each of the 2015/16, 2016/17, and 2017/18 financial years:**

- 1. The total revenue from patients and visitors paying to park their vehicles in any DHB parking space.**

The Canterbury DHB had no paid patient or visitor parking in 2015/16, 2016/17 or 2017/18

- 2. Are any parking spaces provided to employees? If so, what is the total economic value of the parks?**

Yes there are parking spaces provided to Canterbury DHB employees. Some car parks are DHB owned. Others are leased from third parties and subject to a rent charge. Canterbury DHB in turn charges employees for parking as specified in responses to Question 3 and Question 8.

- 3. The total revenue collected from employee parking spaces.**

There are 961 staff parking spaces located within close proximity to Christchurch Hospital from which revenue was:

\$830,524 in 2017/18

\$782,744 in 2016/17 and

\$778,620 in 2015/16 financial years.

Burwood, Hillmorton, Princess Margaret Hospitals, Ashburton Hospital and the Rural Hospitals have extensive free parking (staff and public)

- 4. The total number of DHB parking spaces.**

There are In excess of 2000 parking spaces over ALL the Canterbury DHB sites

**5. The total revenue generated from fines and infringement fees as a result of staff, patients, and visitors parking their vehicles improperly.**

Canterbury DHB does not issue fines or infringements, therefore there was no revenue generated.

**6. The total number of fines and infringement notices issued. Please also disclose the number of fines and infringement notices that were waived.**

Refer to response to Question 5. Canterbury DHB does not issue fines or infringement notices. Employees' vehicles are identified on a parking register and parking permits are displayed on or in the vehicle.

**7. The total cost of the DHBs parking enforcement system. Please ensure to include any payments or wages made to contractors or staff to patrol the DHB parking spaces.**

There are no external enforcement costs. Canterbury DHB security staff can be utilised to monitor the staff car parks.

**8. The current hourly charge for a user to park a vehicle in any DHB parking space. If parking is charged at a time interval other than hourly, please disclose the relevant interval(s) and charge(s).**

Canterbury DHB Staff pay \$26.52 per week for 24/7 parking.

**9. A list of any parking concession charges or exemptions available to patients or visitors.**

Refer to response to Question 1. The Canterbury DHB has no paid patient or visitor parking.
