I refer to your email dated 17 August 2022 requesting the following information under the Official Information Act from Waitaha Canterbury. Specifically:

## 1. How many mental health care workers are employed in the district?

Please see below in **Table one** the breakdown of FTE by discipline and the grand total:

## 5. What is the current average wait time for the first appointment with mental health services?

The current average wait time for the first face to face appointment is 18.2 days.



#### 6. What is the current average wait time to see a psychiatrist?

Specialist Mental Health Service Canterbury does not have waiting lists for people to specifically see a psychiatrist. A new person referred to specialist mental health will be assessed by members of the multi-disciplinary team, which may include a psychiatrist. This assessment is then usually triaged through a multi-disciplinary team meeting, which will include a psychiatrist or a psychiatric registrar.

### 7. How many people were seen by the district's mental health services in 2021, and 2022 so far?

#### 8. Do you have a priority system in place to determine who needs to be seen most urgently?

Priority and urgency is determined by the nature of the presenting issue, severity of illness, level of impairment/distress, and assessed risk to self or others when an individual presents to services. A person's relevant history of mental health difficulties and current supports available are also considered during the triage process.

#### 9. Could you outline the levels and the definitions that align with those priority levels?

There are three levels of response:

- Acute response (same day)
- Urgent assessment (within five days may need support from Crisis Resolution while waiting)
- Routine or non-acute assessment

These levels are determined based on the criteria described in question 8

#### 10. What is the district's definition of a mental health crisis?

There is no district definition of a mental health crisis, however for the purpose of engaging people with services, crisis is used to describe a presentation where there is immediate safety or risk concerns due to the person's mental health presentation or where someone is acutely mentally unwell requiring urgent or immediate assessment and support.

## 11. How much funding has been dedicated to districts' mental health services in the past five years?

**Note:** Funding for CAF mental health service funding includes internal funding for services provided by the former DHB's specialist mental health services team and funding to external providers. Internal funding is allocated on prices determined locally as there are no national prices. For the **2019-2020** financial year these prices were increased. A further review in **2020-2021** found some of the prices required an adjustment to reflect actual cost of service delivery, therefore the funding provided was adjusted to better reflect cost of service delivery. There were no material changes in services delivered across these years, the decrease in funding reflects the adjusted prices.
