RE Official information request CDHB 9930

We refer to your email dated 28 August 2018 requesting the following information under the Official Information Act from Canterbury DHB.

Can you provide an update for buildings at Hillmorton, Burwood, Christchurch Women's, clinical services block and Parkside covering:

We have previously provided you/[REDACTED] with Detailed Engineering Assessments for:

- Christchurch Womens;
- Clinical Services Building;
- Parkside (Christchurch campus);
- Hillmorton Hospital campus; and
- Burwood Hospital campus.

Current earthquake prone status (i.e. building capacity)

The Christchurch City Council maintain the Earthquake Prone Buildings' Register which is available at <https://epbr.building.govt.nz/>. This Register lists the DHB earthquake prone buildings.

Repairs/strengthening completed to date and planned repairs

We refer you to our response for OIA CDHB 9881 which is published on our website <http://www.cdhb.health.nz/About-CDHB/oia/responses/Pages/default.aspx>; where we released the monthly Facilities Reports (including the Quarterly Reports) for the last six months. These reports summarise the repairs ongoing/completed to date and also those planned (may be subject to DHB Board approval). There was no report for March.

Please note that the programme of works is continually subject to review, prioritisation and change. Information regarding budgets for repairs yet to be completed is either not held (as budgets are yet to be allocated/approved) and/or withheld pursuant to 9(2)(b)(ii) on the basis that disclosure of such information could result in commercial prejudice where the work is yet to be tendered.

Budget for repair work to do. Will planned earthquake repairs be paid for out of the CDHB's operational budget - or will they be partially funded by insurance and partly operational budget?

The damage to the DHB buildings and infrastructure incurred as a result of the Canterbury Earthquakes exceeded the DHB's cap on insurance. Canterbury DHB's earthquake remediation programme of works is largely funded from the insurance proceeds received. The shortfall ultimately has to be met either through operational capital as available and additional funding yet to be identified/allocated.

I trust that this satisfies your interest in this matter.

If you disagree with our decision to withhold information you may, under section 28(3) of the Official Information Act, seek an investigation and review of our decision from the Ombudsman.

Please note that this response, or an edited version of this response, may be published on the Canterbury DHB website after your receipt of this response.
