I refer to your email dated 2 November requesting the following information under the Official Information Act from Canterbury DHB. Specifically:

Can you let me have the most recent population information provided to the CDHB by Statistics NZ? Including any breakdowns by ethnicity, age, sex, deprivation index

Please refer to **Appendix 1** (attached) for the latest population projections Canterbury DHB received as part of the 2020/21 planning package in early 2020. They were produced by StatsNZ specifically for the Ministry of Health and should be referred to as "Projections produced by Stats NZ according to assumptions agreed to by the Ministry of Health".

We have included the population projection for the 2020/21 financial year as summaries for sex, age group and ethnicity (Maori/Pacific/Asian/Other) totals, as well as a table that includes all groups.

The deprivation index is not created by StatsNZ, and is not included in the population projection figures supplied to DHBs. The deprivation index is produced by the University of Otago following each census (currently NZDep2013 Index of Deprivation), with the index being applied to the funded population each year by the Ministry of Health.
